Dean's Decree 1/2016

Financial conditions of Advanced Master's State Examination in the English study programme "Pharmacy" at the Faculty of Pharmacy, UVPS Brno, for 2016

The Decree is issued in accordance with § 46 para. 5 of the Law 111/1998, as amended on the basis of § 13 of the Advanced Master's State Examination Provisions of the Faculty of Pharmacy, UVPS Brno.

The amount of the fee is determined by the relationship of the applicant to UVPS Brno and the method of implementation of the Advanced Master's State Examination.

All applicants will pay a fixed part of the fee 80 EUR for administrative work and the issue of the diploma, the variable part is determined by the method of implementation of the Advanced Master's State Thesis and Examination.

For the purpose of calculating the fee for the Advanced Master's State Examination process, candidates are divided into three groups:

1st Group of Applicants

This group includes students of the English postgraduate study programme Pharmacy. These candidates pay only a fixed part of the fee EUR 80 for administrative work and the issue of the diploma.

2nd Group of Applicants

This group includes candidates who are not members of the 1st group and who will develop their Advanced Master's State Thesis without the right to use the University facilities (laboratories and equipment).

For their Advanced Master's State Examination management, these candidates will pay the total amount of EUR 1 600, which includes a fixed part of the fee EUR 80 for administrative work and the issue of the diploma and the amount of EUR 1 520 for access to information technologies and the access to consultations on the Faculty of Pharmacy UVPS Brno.

3rd Group of Applicants

This group includes candidates who are not members of the 1st group and who will develop their Advanced Master's State Thesis with the right to use University facilities (laboratories and equipment).

These candidates will pay for their Advanced Master's State Examination management the total amount of EUR 2 000, which includes a fixed part of the fee EUR 80 for administrative

work and the issue of the diploma, the amount of EUR 1 520 for access to information technologies and access to consultations on the Faculty of Pharmacy UVPS Brno and the amount of EUR 400 which gives them the right to use University facilities (laboratories and equipment including consumables).

Acceptance of applications, their assessment and evaluation of the Advanced Master's State Examination is included in the educational activities of the University in accordance with Act No. 111/1998 Coll. as amended, and related regulations.
