have concluded the following agreement:

I.

Subject of Agreement

The contracting parties have concluded this Agreement to formalize the studies of Student in the English Master`s Degree Study Programme of the Faculty.

II.

Undertakings by the Contractual Parties

In order to realise the subject of the Agreement, the parties undertake the following:

1. Undertakings by Faculty:

1.a Faculty shall provide Student with education in the English Master`s Degree Study Programme “Pharmacy”, compliant with the 2005/36/EC directive of the European Union and accredited by the Ministry of Education, Youth and Sports of the Czech Republic.

1.b This education is carried out within valid laws and regulations of the Czech Republic, including the Act No. 111/1998 in valid wording and the Study and Examination Regulation of the Credit System of Study at the University of Veterinary and Pharmaceutical Sciences Brno, which is attached to this Agreement.

1.c The standard duration of study in the English Master`s Degree Study Programme “Pharmacy” is 5 years. Faculty will award Student with the degree after fulfilling all the conditions given by the Study and Examination Regulation.

1.d Faculty shall offer dormitory (or other with similar standards) accommodation to Student in, and only in, his/her first year of study. The cost of this accommodation will be paid by Student.

Student has to ask the Study Officer for his/her place in the dormitory at least 2 months before the beginning of the academic year.

1.e Faculty shall appoint a Study Office for students to discuss issues pertaining to their studies. The language spoken will be English.

2. Undertakings by Students

2.a Student hereby confirms that he/she has been acquainted with valid laws and regulations issued by UVPS, including the Study and Examination Regulation of the Credit System of Study at the University of Veterinary and Pharmaceutical Sciences Brno.

2.b Student hereby confirms, that he/she has a finished secondary education. Student was informed that according to Law 111/1998 Coll. only students with finished secondary education are entitled to be accepted to studies at universities in the Czech Republic and that the secondary education of foreign students is evaluated by the Regional Government Authority. Student is obligated to provide the faculty with the document issued by the Regional Government Authority confirming the validity of Student's secondary education in his/her 1st year of study at the Faculty (in case of EU residents) or 3rd year of study at the Faculty (in case of other Students) at the latest.

2.c Student is obliged to pay a tuition fee for every academic year prior to enrolment to studies that year and before the start of the academic year.

2.d Instructions on how to proceed with paying the tuition fee shall be available at the Study Office prior to the beginning of every academic year. It is the duty of Student to acquaint himself/herself with these instructions and realize payments according to these instructions.

2.e Submitting the proof of paying the tuition fee is a prerequisite to enrolment to studies every academic year. Based on this proof of payment the Accounting Department of the University confirms acceptance of Student's tuition fee payment. If the Accounting Department of the University can't confirm the paying of the tuition fee, the burden of proof is with the Student.

2.f Student has been acquainted with the cost of the tuition fee as well as the fact that this does not cover the cost of living, medical insurance and other expenses which have to be covered by Student.

2.g Arranging accommodation for Students, other than Students in their first year of study, is not subject of this agreement and shall be a private business of the individual students.

2.h Student understands that Faculty shall not be responsible for making arrangements for visits by relatives or friends of students.

2.i Student understands that he/she is obliged to arrange medical insurance on his/her expenses. Student is responsible for insurance coverage of loss or damage caused to the Faculty or other Party during Student's stay in the Czech Republic.

2.j In case of Student's breaking the obligations given by this Agreement, his/her studies can be terminated with no reimbursement of the tuition fee already paid.

If the Student's studies are terminated for not fulfilling the Study Plan according to the Study and Examination Regulation or on the Student's request, the fees already paid are not reimbursed.

III.

Special Arrangements

1. The tuition fee is set at 6 700 Euro for the academic year 2018/19. UVPS reserves the right to change one-sidedly the amount of the set tuition fee every academic year, but by no more than 10 per cent of the tuition fee for the previous academic year. The tuition fee can only be changed once for every Student during his/her study.

2. The Faculty undertakes to always inform Student of a possible modification of the tuition fee for the next academic year not later than by 31 May of the current calendar year.

3. In the case that Student doesn't pay the tuition fee within the appointed terms, it will be considered an infraction against UVPS regulations and his/her studies can be terminated one month after this term.

4. Faculty guarantees that the English Master's Degree Study Programme "Pharmacy" is compliant with the 2005/36/EC directive of the European Union. However, Faculty is not responsible for recognition of this study outside of the Czech Republic. Student has to inform himself/herself at the responsible authority in his (or any other) country, especially in the case the studies at the Faculty take less than the five standard years due to recognition of previous studies or other reasons.

IV.

Concluding Regulations

1. By signing of this Agreement both contracting parties declare that they have read this Agreement, understand its meaning and intent, agree to all the rights and duties which are stated in this Agreement and are entering this Agreement knowingly and voluntarily.

2. This Agreement is printed in two copies in the English language. Each contracting party shall keep one copy.

3. This Agreement goes into effect by the date of signing by both parties.
